WHAT IS KIDSPORT™?

KidSport™ is a children's charity. KidSport™ assists children by overcoming financial barriers, which prevent or limit their participation in organized sport.

KIDSPORT™ FUNDING

The KidSport™ Fund is sustained by contributions from individuals and corporate sponsors and donations will vary from year to year. Eligibility does not ensure assistance. Financial assistance may be less than amount requested. Previous funding through KidSport does not guarantee assistance in following years.

ELIGIBILITY GUIDELINES:

Please read the following guidelines carefully before completing this form.

- Financial assistance to individual athletes is designed to help those who would not play a sport without KidSport™.
- Financial assistance is disbursed up to a maximum of \$200 in a calendar year per athlete.
- KidSport™ assists children aged 5 to 17.
- Preference is given to athletes who are being introduced into organized sport.
- Sport activities must be affiliated with organizations recognized by Sport Manitoba.
- Financial assistance is given for structured sport activities led by a qualified coach.
- Costs relating to camps, travel, championships, etc. do not qualify.
- The KidSport™ program issues cheques directly to the organization on behalf of the athlete.
- Copies of Canada Customs and Revenue Agency Notice of Assessment must be provided as requested in Step 3 of this application. **Applications will not be processed without these forms.**
